A highlight to the hotel is an expansive outdoor patio area, which connects with BB Jack’s, a popular restaurant and bar that features an extensive game room, televisions for viewing sporting events, and occasional live entertainment.

Construction on the property lasted a little over a year and was completed by Consolidated Construction Company, Inc., headquartered in Appleton, WI. The Comfort Suites in Cottage Grove is part of an updated effort by the brand to emphasize exceptional guest experiences. The hotel is being constructed with an insulated concrete form (ICF) system, which is considered a higher end construction product than the traditional stick-built wood frame structures utilized by most hotels. The ICF system provides superior sound insulation, temperature control, and energy efficiency.

"This property is a new prototype for Choice Hotels, and it was built to be extremely energy efficient and soundproof. The architects did a great job accomplishing those goals," said Wagner.
