Door County Green Fund Unveils Multi-Modal Trails Maps and Report

June 26, 2024 – Sturgeon Bay, Wisconsin

The Door County Green Fund, a fund of the Door County Community Foundation, is proud to announce the public unveiling of the Door County Multi-Modal Trails Task Force Report: A collection of resources and maps to help Door County communities develop a comprehensive and connected trail system.

Door County is home to an abundance of dynamic trails used by walkers, hikers, and bikers alike. However, between 19 municipalities, 5 school districts, and countless non-profit organizations, coordinating the stewardship of Door County's trails can be difficult. In 2022, the Door County Green Fund convened an ad hoc group of government officials, environmental groups, and trail enthusiasts to foster better communication toward the ultimate goal of a seamless network of trails connecting the entire county.

The Green Fund contracted with Sophie Parr of Civic 4, LLC to communicate with municipalities and other major non-profit, government and individual trail property owners to document their existing trails and capture their future plans in a comprehensive map.

This new report outlines all trail related projects, both existing and planned, throughout the entirety of Door County with the purpose of creating greater awareness and communication between communities to aid in the development of trails. Included in the report are several regional maps, making it easy to view opportunities for walking, jogging, biking, and the like throughout Door County.



The Door County Trail Initiative, in partnership with Destination Door County and various community stakeholders, will use the report to facilitate conversations about trail development as part of the Door County Stewardship Plan.
